 - The institution shall make admission only after it obtains affiliation from 111. the examining body in terms of clause 8(12) of the NCTE(Recognition Norms & Procedure) Regulations, 2007.
 - The institution shall ensure that the required number of academic staff IV. for conducting the course is always in position.
 - 5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its-Web-site as per provisions of NCTE 6. Regulations and always display following as mandatory disclosure:-
 - Copy of the Application Form (i)
 - Land and Building Particulars (ii)
 - (iii) Staff Profile
 - Recognition letter (iv)
 - Information for having fulfilled the norms & standard and other required (V)
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders-made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
